EXHIBIT STATEMENT:

This exhibit is an opportunity for DCCA members to showcase their own original artwork without themed guidelines. If your membership is not current, this is a great time to renew. Entries will be limited to an exhibition of 60 pieces of artwork. Entries will be juried as to appropriateness for public display. Let your creativity, skill, heart, and soul shine for this special event.

ELEGIBILITY:

- Artists must be a current member of the DCCA
- Art works must be original — no kits to be used
- Art works must NOT have been shown before in this Gallery
- Wall hung art must be framed and wired for hanging
- Mat color: white or pale neutrals
- No diptychs or triptychs
- Framed artwork, including frame, not to exceed 4' x 4'
- Floor 3D art not to exceed 6' x 6'
- Wall hung art not to exceed 30 pounds
- Sculpture and floor displays must be stable and light, moveable by 2 persons

The exhibit committee has the discretion not to accept any artwork that does not meet any criteria.

MEDIA:

- Open to all 2 & 3 dimensional Fine Art
- Photography—clearly identify creative process used

SALES:

- Information from the entry form is used for multiple purposes such as inventory lists, and wall labels. Therefore, we ask that you make no changes in title, price or substitute another painting once the form is submitted
- If you painting is NOT FOR SALE (NFS), please state its value for insurance purposes.

COMMISSIONS:

- DCCA will sell art works only at retail price on Artist's Application Form
- DCCA and artist agree that 35% of the retail price will be due to the DCCA

SALES TAX:

DCCA assumes all responsibilities to collect and pay the appropriate WI state and county sales tax on all works sold. Sales tax will be added to the retail price of the work as established by the Artist.
